4. On expiry, the Identity Cards must be submitted to the National Admn. Office. After expiry, renewal is a must for regular membership.
5. In case of change of address, Member should inform the same to the National Admn. Office.
6. In case of loss of the identity Card, inform the National Admn. Office in writing along with the F.I.R. immediately.
7. All AIHRA members should contact their respective Area Units / State Units / National Admn. Office once in a month.
8. Applicant can use photocopy of the application form which will be duly acknowledged by the National Admn. Office once received duly filled in.
9. Strict action will be taken against the Member, if found guilty floating the rules and regulations of AIHRA, and are also punishable under the Press & Societies Act.
